

**PUERTO RICO ELECTRIC POWER AUTHORITY**  
**PROFESSIONAL SERVICES CONTRACT 2019-P00090 A**  
**FIRST AMENDMENT**

**APPEAR**

AS FIRST PARTY: The Puerto Rico Electric Power Authority (PREPA), a public corporation and government instrumentality of the Commonwealth of Puerto Rico, created by Act 83 of May 2, 1941 (Act 83), as amended, represented in this act by its Chief Executive Officer/Executive Director, mister José F. Ortiz Vázquez, of legal age, married, engineer, and resident of San Juan, Puerto Rico. ----

**AS SECOND PARTY:** SayNet, Inc. (SN), a corporation organized and registered to do business in Puerto Rico, represented in this act by its President, Nelson Orwil Traverso Rodríguez, of legal age, married, and resident of Toa Alta, Puerto Rico, duly authorized to appear in representation of SN by Resolution dated April 2, 2019.-----

Both PREPA and SN are herein individuals referred to as a "Party" and collectively referred to as the "Parties". -----

WITNESSETH

WHEREAS, PREPA, by virtue of Act 83, has the authority to engage those professional, technical and consulting services necessary and convenient to the activities, programs, and operations of PREPA;-----

WHEREAS, Pursuant to Section 205 (2) (d) of Act 83, competitive bidding shall not be necessary when professional or expert services or work are required and PREPA deems it in the best interests of good administration for such works or services to be contracted without such announcements. -----

WHEREAS: The Appearing Parties executed Professional Services Contract 2019-P00090 on April 8, 2019, with a maximum amount of two hundred eighty thousand dollars (\$280,000) and effective until June 30, 2019. -----



WHEREAS: It is necessary to increase the maximum amount of the Contract by two hundred eighteen thousand five hundred dollars (\$218,500) until June 30, 2019, to cover the additional services required by Finance Directorate. -----

NOW THEREFORE, in consideration of the mutual agreements and the terms and conditions set forth herein, PREPA and SN agree as follows: -----

TERMS AND CONDITIONS

FIRST: The Parties agree to amend item 4.2, of Article 4 of the Contract, to increase the Contract Amount by two hundred eighteen thousand five hundred dollars (\$218,500), from two hundred eighty thousand dollars (\$280,000) to four hundred ninety-eight thousand five hundred dollars (\$498,500). The payment to be made under this First Amendment will be charged to account 01-4026-93503-550-139. -----

The remaining sentences and paragraphs of Article 4 of the Contract not affected by this Amendment shall remain unaltered and fully enforceable. -----


SECOND: Payment for services object of this Contract will not be made until this First Amendment is properly registered in the Office of the Comptroller of the Government of Puerto Rico pursuant to Act 18 of October 30, 1975, as amended. -----


THIRD: All other terms and conditions, stipulations, insurances and requirements established in the Contract shall remain unaltered and fully enforceable. -----
