APPEAR

AS FIRST PARTY: The Puerto Rico Electric Power Authority (PREPA), a public corporation and government instrumentality of the Commonwealth of Puerto Rico, created by Act 83 of May 2, 1941 (Act 83), as amended, represented in this act by its Chief Executive Officer, José F. Ortiz Vázquez, of legal age, married and resident of San Juan, Puerto Rico. -----

AS SECOND PARTY: Tetra Tech Inc, hereinafter referred to as "TETRA TECH", a for profit corporation organized under the laws of the State of Delaware and registered to do business in Puerto Rico under registry number 11847, represented in this act by its Director, Fernando L. Pagés Rangel, of legal age married and resident of Carolina, Puerto Rico, duly authorized to appear by Resolution/Certification dated June 3,2020.---

Both PREPA and TETRA TECH are herein individually referred to as a "Party" and collectively referred to as the "Parties". -----

WITNESSETH

WHEREAS, PREPA, by virtue of Act 83 has the authority to engage those professional, technical and consulting services necessary and convenient to the activities, programs and operations of PREPA;-----



NOW, THEREFORE, in consideration of the mutual covenants and agreements contained in this Contract, hereinafter stated, the Parties agree themselves, their personal representatives, and successors to enter into this Amendment under the following: -----

STATE

WHEREAS: The appearing Parties executed Contract 2020-P00099 (Contract) on May 7, 2020, for damages assessment caused during Hurricane Maria to the Guajataca Dam and the development of technical specifications for the permanent repairs of the damages. The Contract had a maximum amount of two hundred thousand dollars (\$200,000) (Contract Amount), and is effective until June 30, 2020.-----

WHEREAS: PREPA's Disaster Funding Management Office (DFMO), requested a First Amendment to extend the Contract term for six month, until December 31, 2020, without any increase in Contract maximum amount.-----

THEREFORE: In order to continue receiving Tetra Tech services the appearing Parties hereby agree to enter into this First Amendment under the following: -----


TERMS AND CONDITIONS

FIRST: The Parties agree to amend Article 4 of the Contract to extend its term until December 31, 2020, without any increase in the Contract Amount. The payments to be made under the Contract, as amended, will be made from account 01-1747-17556-555-664. -----


