TO PROFESSIONAL SERVICES CONTRACT 2021-P00033B

APPEAR

AS FIRST PARTY: Puerto Rico Electric Power Authority, hereinafter referred to as "PREPA", a public corporation and government instrumentality of the Commonwealth of Puerto Rico, created by Act of May 2, 1941, No. 83, as amended, represented in this act by its Interim Executive Director, Mister Efran Paredes Maisonet, of legal age, married, engineer, and resident of Bayamón, Puerto Rico. -----

AS SECOND PARTY: Baker Donelson, Bearman, Caldwell & Berkowitz, PC (Consultant), a professional corporation organized under the laws of the State of Tennessee, with offices at Suite 900, 901K Street NW, Washington, D.C., herein represented by its Of Counsel, Ernest B. Abbott, of legal age, married, executive and a resident of the Commonwealth of Virginia, duly authorized to appear on behalf of the Contractor.-----

Both PREPA and the Contractor are herein individuals referred to as a Party and collectively referred to as the Parties. -----

WITNESSETH

In consideration of the mutual covenants and agreements contained in this Second Amendment, hereinafter stated, the Parties agree themselves, as follows: -----

STATE

WHEREAS: The appearing Parties executed Professional Services Contract number 2021-P00033 (Contract) on July 1, 2020, through which Consultant would provide PREPA legal analysis, advice, representation, and opinions, as requested by PREPA, in investigations and audits by the Office of the Inspector General, and other matters related to federal funding by the Federal Emergency Management Agency (FEMA) and the U.S. Department of Housing and Urban Development, among others.-----

WHEREAS: On September 30, 2020, the Parties executed the First Amendment to the Contract, in order to, among other things, extend its term from October 1, 2020 to June 30, 2021, increase its maximum amount to one million five hundred thousand dollars (\$1,500,000) and to update the Appendix A, Rate Sheet. -----

WHEREAS: PREPA has assigned new matters for which the Consultant has to include in the Appendix A, Rate Sheet, additional attorneys with expertise in said new matters. -

THEREFORE: The appearing Parties hereby agree to enter into this Second Amendment under the following: -----


TERMS AND CONDITIONS

FIRST: The Parties agree to update the Rate Sheet. The updated Appendix A Rate Sheet is included with this Second Amendment. -----


SECOND: All other terms and conditions, specifications, stipulations, insurances and requirements established in the Contract remain unaltered and fully enforceable. -----
