

Rating Update: Moody's downgrades PREPA to Baa2 from Baa1; PREPA remains under review for possible further downgrade

NEW YORK, December 17, 2012 --Moody's Investors Service has downgraded to Baa2 from Baa1 the rating on the Puerto Rico Electric Power Authority's (PREPA) approximately \$8.0 billion of outstanding power revenue bonds. The rating remains under review for possible further downgrade.

RATINGS RATIONALE

Today's action is based on the recent downgrade of the Commonwealth of Puerto Rico's general obligation rating to Baa3 with a negative outlook as well as the downgrade of entities that are based on or capped at the GO rating, including the Government Development Bank of Puerto Rico, which is an important source of liquidity for PREPA.

Our review will focus, among other things, on how closely the rating of PREPA should track the rating of the Commonwealth of Puerto Rico. Moody's notes that the rating of PREPA has not fallen below that of the Commonwealth. PREPA operates as the sole provider of an essential service. The review will also focus on (i) the sources of PREPA's liquidity given the recent downgrade of the Government Development Bank of Puerto Rico; (ii) an analysis of the audited financial information for fiscal year 2012; (iii) the plans of the incoming management team to implement recommended cost cutting measures; and (iv) the recent abandonment of the Via Verde gas pipeline and its effect on the authority's natural gas conversion plan.

Strengths

- *PREPA continues to operate as the sole provider of an essential service, historically independent from the Commonwealth's finances and with liquidity support from the Government Development Bank of Puerto Rico
- *The board has full rate-setting authority. PREPA can automatically pass through to customers higher fuel and energy costs on a monthly basis
- *Sound bond covenants including a requirement that maximum annual debt service is covered 1.20x
- *PREPA has also continued to better position the utility with its power resource diversity plan

Challenges

- *Significant dominance of fuel oil as a percentage of total generation fuel mix has subjected PREPA to price volatility
- *Accounts receivable problem has historically been a pressure on cash flow
- *Debt leverage is above median for major public power utilities that own generation
- *Frequent changes to executive management continue to provide some instability
- *Natural gas conversion plan is unclear given the abandonment of Via Verde pipeline project
- *Internal financial liquidity is weak
